

Memorandum of Agreement – Amendment No. 4
Between Hartland Township, Hartland Area Youth Athletic Association (HAYAA)
and Hartland Community Soccer Association (HCSA) and Hartland Youth Lacrosse (HYL)

WHEREAS, Hartland Township (the “Township”) constructed a public park (the “Park”) on Highland Road (M-59), west of Fenton Road, and provided athletic fields for the Hartland Area Youth Athletic Association (“HAYAA”) and Hartland Community Soccer Association (“HCSA”) and Hartland Youth Lacrosse (HYL);

WHEREAS, the Township, HAYAA and HCSA and HYL (the “Parties”) entered into a Memorandum of Agreement (“Agreement”) in 2012 regarding the apportionment of cost, use, maintenance and preservation of the Irrigation, fields, parking lot and driveways in the Park; and

WHEREAS, the Parties desire to amend the Agreement to further clarify the cost, use and maintenance of the Park; and

WHEREAS, the Township has determined that this Amendment is in the public interest and serves and advances a public purpose,

NOW, THEREFORE, the Parties agree to amend the following language of the agreement for the sections noted:

REPLACE section VIII “The Township shall apply all credits accrued as provided above to the Township’s payments outlined above, with the following credit adjustments per month:

- a. Two Hundred Dollars (\$200.00) for HYL
- b. Two Hundred Dollars (\$200.00) for HAYAA
- c. Two Hundred Sixty-Six Dollars (\$266.00) for HCSA”

ADD a new Section VIII to read: “The Township shall apply all credits accrued as provided above to the Township’s payments outlined above, with the following credit adjustments per month:

- a. Two Hundred Dollars (\$200.00) for HYL towards irrigation until balance is satisfied
- b. One hundred Eighty-Five Dollars (\$185.00) for HYL for storage unit
- c. Two Hundred Dollars (\$200.00) for HAYAA towards irrigation until balance is satisfied
- d. One hundred Eighty-Five Dollars (\$185.00) for HAYAA for storage unit
- e. Two Hundred Twenty-Five Dollars (\$225.00) for HCSA for storage unit and concession stand”

The current HAYAA irrigation balance for the recreation partners is as follows:

HYL: \$8,409.81
HAYAA: \$8,409.81
HCSA: Paid in full
